### PROGRAMME DESCRIPTION

The primary objective of the programme is to develop a novel framework for specialists who possess fundamental knowledge, and professional competencies in the field of developing and implementing legal norms, ensuring legality and law and order, legal education, and upbringing.

#### The programme develops the following learning outcomes:

- Understanding the fundamentals of the constitutional system, the structure, functions, and principles of activity of state bodies, the essence, character, and interaction of legal and governmental phenomena.
- Comprehending the essence of law as a regulator of social relations, knowledge of the functions of law, the structure, and elements of the legal system, the regularities of the origin of the state, forms, and methods of performing the functions of the modern state.
- Demonstrating skills in academic and business writing, the ability to distinguish writing styles, correctly drafting legal documents, and providing qualified oral consultations (in Kazakh, Russian, and English languages).
- Being able to apply the norms of substantive and procedural law to specific life situations, accurately qualify facts and circumstances from a legal perspective, possess skills in argumentation and legal analysis, and construct algorithms for solving cases and situational tasks.
- Awareness of the possible consequences of one's activities and the need to take responsibility for them.
- Proficiency in the fundamentals of programming languages, effective communication techniques, and their application in practical activities, clear and precise communication with others.
- Critical thinking and the ability to act independently in solving practical and legal problems, the ability to address complex legal issues both individually and in a group.
- Applying the norms of international and national law to protect and secure the rights and interests of individuals and legal entities.

- Being able to independently search, collect, and analyze legal and other information, including materials from judicial practice.
- Understanding criminal and administrative procedures, civil law, and disciplinary procedures.
- Demonstrating skills in the application of alternative dispute resolution methods and legal techniques.
- Understanding the differences and specifics of various legal systems.
- Being able to make decisions and carry out other legal actions in strict accordance with the law, showing respect for law and legislation, and being intolerant of corrupt behavior.

### **What will I be expected to achieve?**

#### **On successful completion of this programme, you will be expected to be able to:**

##### To know and understand:

- The legal system and legislative framework, and the practice of its application.
- The role and place of legal branches within the legal system.
- The content of subjective rights, the procedures for their realization and protection, the subjects and objects of law, and types and forms of legal liability.

##### To be able to:

- Accurately interpret legislative norms.
- Apply legislative norms when solving various legal issues.
- Logically and coherently argue a position when resolving specific cases.
- Properly identify and qualify legal facts.
- Provide qualified legal opinions and consultations on legal issues.

##### To possess:

- Skills in using legal terminology.
- Skills in applying fundamental legal doctrines and principles of law in interpreting legal provisions.
- Skills in working with legal acts.
- Skills in analyzing legal facts, legal norms, and legal relationships.
- Skills in analyzing legal precedents.
- Skills in resolving legal problems and conflicts.

### **HOW WILL I LEARN**

Teaching is conducted both within the framework of classroom contact hours and using a blended format and other methods. Specifically, certain skills are reinforced through participation in academic clubs, and practical skills can be enhanced not only through internships but also by participating in the Legal Clinic.

You will have the opportunity to conduct independent research under the guidance of research school leaders, utilizing library resources.

During classroom sessions, case studies are actively employed, allowing you to acquire practical problem-solving skills in legal matters.

Additionally, you will be offered courses in academic and legal writing, philosophy, and legal ethics. These courses will enable you to expand your research and analytical skills, as well as your writing skills

## **WHAT TYPES OF ASSESSMENT AND FEEDBACK CAN I EXPECT?**

### **Grading and Evaluation Criteria**

The programme includes various types of assessed tasks, such as case studies, analytical and group assignments, essays, quizzes, and other forms of assessment within a cumulative grading system and as part of the final examination. Detailed evaluation criteria for each type of assessed task are provided in the course syllabus. Access to syllabus containing such criteria is available in the LMS "Canvas."

For all types of non-classroom assignments that involve assessment (internship evaluations, defense of thesis projects, state examinations, etc.), a criteria-based approach to evaluation is also employed. These criteria will be outlined in the respective programmes and policies available on the university's website.

### **Overall, you can expect four types of assessment:**

1. Examinations for several courses upon completion of their study.
2. Cumulative assessment based on course outcomes.
3. Internship defense.
4. Final assignment upon programme completion (state examinations and diploma project defense).

Examinations are scheduled for subjects offered for final assignment. These subjects include:

1. Гражданское право Республики Казахстан I, II, III;
2. Уголовное право Республики Казахстан I, II;
3. Теория государства и права;
4. Конституционное право Республики Казахстан;
5. Профессиональный казахский (русский) язык;
6. Юридическое письмо;
7. Гражданское процессуальное право Республики Казахстан.

По всем остальным дисциплинам предусмотрена накопительная система оценивания.

Итоговая государственная аттестация предполагает сдачу комплексного государственного экзамена по Гражданскому и Гражданскому процессуальному

праву и защиты дипломного проекта (работы). В случаях, определенных академической политикой университета, защиты дипломного проекта (работы) заменяется на два комплексных государственных экзамена: 1) Комплексный экзамен по публичному праву (теория государства и права и конституционное право Республики Казахстан); 2) Комплексный экзамен по профессиональному казахскому (русскому) языку и юридическому письму.

There are two types of LLB final thesis: Diploma Project and Diploma thesis. A Diploma Project is a research group work, carried out by order of the University with the condition of a pyramidal system (PhD – Master – Bachelor research) or by order of a third-party organization within the framework of priority research areas. A Project is written by a group of 3 to 5 students, and all students in the group must meet the requirements of GPA 3.0 at the time of applying for the project. A Diploma thesis is a group work carried out within the framework of the priority research areas, aimed at preparing intermediate results, implemented in the form of comments to articles (norms, provisions) of legislation or international treaties determined by the managers of the priority research areas. A thesis is written by a group of 3 students. All pre-assessed projects and thesis are subject to public defense in a State Attestation Commission. ## **INTERNSHIP AND CAREER**

Within your academic journey, during your third and fourth years, you will engage in three distinct forms of practical experience: Training Practice, Thesis Practice, and Working Practice. These placements are facilitated by The Centre of Professional Internship, Career, and Employment. It's important to note that achieving a strong academic performance in your studies heightens your likelihood of securing placements in prestigious law firms and organizations, as these entities often prioritize students with high GPAs.

The Centre of Professional Internship, Career and Employment organizes internships; career days (annual Legal Month – activities of employers during 3 weeks); annual Job fair; KAZGUU Law School Business Council; annual survey of graduates and employers; and analyzes the job market.

Within the framework of promoting the development of career skills of students and the successful employment of graduates, effective forms of cooperation with employers Centre of professional internship, career and employment annually organized and conduct Legal month of KAZGUU Law School. Since 2020 KAZGUU Legal month is conducted for the 1st year students in order to introduce with the specificity of current employers -business partners of the KAZGUU Law School. The purpose of this event is to orientate 1st year students to choose further specialization in the learning process. ## **HOW ARE MY ACHIEVEMENTS ACKNOWLEDGED UPON GRADUATION?**

There are three levels of degrees:

1. With Honors (Cum laude),
2. With High Honors (Magna cum laude),
3. With Highest Honors (Summa cum laude).

The With Honors designation is indicated on a specialized diploma format.

In order to be awarded the Summa cum laude diploma (With Highest Honors), the student must maintain a GPA of 4.0. To earn a Magna cum laude (With High Honors) diploma, a GPA of 3.8 - 3.9 is required, accompanied by grades of "good" and "excellent". Similarly, to receive a Cum laude (With Honors) diploma, the student's GPA should fall between 3.5 - 3.7, along with "good" and "excellent" grades."
